

# Terms and Conditions

## Overview

Welcome to ACG's Website, operated by Association for Corporate Growth, Inc. (collectively with its chapters and any other affiliates, "ACG", "we" or "us") at [www.acg.org](http://www.acg.org) and [www.acg.org/\[name of chapter\]](http://www.acg.org/[name of chapter]) (collectively, the "Website" and/or "Websites"). These Terms of Use govern the use of the Website by any person viewing the Website(s) or using the Website ("User" or "you").

Please read these Terms of Use carefully. By using, accessing or browsing the Website you acknowledge that you understand and agree to and all terms and conditions contained in these Terms of Use. If you object to anything in these Terms of Use or any policy we may post or maintain on the Website from time to time, do not use the Website. The Terms of Use are subject to change at any time, effective upon posting on the Website, and your use of the Website after such changes will constitute acceptance by you of such changes.
