Hon. David Norquist Biography

David L. Norquist is the CEO of the National Defense Industrial Association ("NDIA"). He joined NDIA on May 1, 2022, bringing with him more than 30 years of public and private sector experience in national security and federal financial management.


Mr. Norquist previously served as the 34th Deputy Secretary of Defense from 2019 to 2021 and was responsible for the day-to-day operations of the Department of Defense ("DoD"), including managing the Pentagon's budget and personnel. He led reforms in DoD business processes and realigned investments toward the challenges of multi-domain warfare. At the request of the Biden Administration, Mr. Norquist served as Acting Secretary of Defense and continued as Deputy Secretary until the Senate confirmed Secretary Lloyd Austin and Deputy Secretary Kathleen Hicks.

From 2017 until 2019, as the Under Secretary of Defense and CFO, he supported the National Defense Strategy through the development and execution of the DoD's annual budget of more than \$680 billion. Mr. Norquist strengthened accountability to the taxpayer by implementing DoD's first department-wide financial statement audit. Mr. Norquist began his career in 1989 as a Presidential Management Fellow, supporting Army intelligence as a program and budget analyst.

Mr. Norquist was born in Concord, MA. He is a 1989 graduate of the University of Michigan, where he received a Master's in Public Policy and B.A. in Political Science. He also holds an M.A. in National Security Studies from Georgetown University.

General (Ret.) Frank McKenzie Biography

Frank McKenzie is a retired general of the U.S. Marine Corps. Currently, he serves as the Executive Director of the University of South Florida's Global and National Security Institute. In July 2022, he also became the Executive Director of the Florida Center for Cybersecurity, also known as Cyber Florida.

He has commanded at the platoon, company, battalion, Marine Expeditionary Unit ("MEU"), and component levels. As a lieutenant colonel, he commanded First Battalion, Sixth Marines. As the Commanding Officer of the 22nd MEU, he led combat deployments to Afghanistan in 2004 and Iraq in 2005 – 2006. In 2006 – 2007, he served as the Military Secretary to the 33rd and 34th Commandants of the Marine Corps.

Upon promotion to Brigadier General in July 2007, he served on the Joint Staff as a Deputy Director of Operations within the National Military Command Center. In June 2008, he was selected by the Chairman of the Joint Chiefs of Staff to be the Director of the Chairman's New Administration Transition Team.

He is currently the President of the Board of Directors of the Institute of Applied Engineering at the University of South Florida, a distinguished senior fellow on National Security at the Middle East Institute, a member of the International Advisory Committee of the National Council on U.S. Arab relations, and a member of the National Security Advisory Council, U.S. Global Leadership Coalition. In March 2024, he was named the Hertog Distinguished Fellow for the Jewish Institute for National Security of America. He is a member of the Florida Council of 100.

Jennifer Swanson is the Deputy Assistant Secretary of the U.S. Army. She works within the Office of the Assistant Secretary of the Army for Acquisition, Logistics, and Technology ("ASA(ALT)"). In this position, Ms. Swanson leads implementation of modern software practices, including agile software development & DevSecOps, data centricity, and digital engineering. She has established a Unified Data Reference Architecture, which will enable digital transformation by giving program managers and industry partners guidance on how to produce, share, and consume data. At the direction of the Vice Chief of Staff, she co-led a capability portfolio review, securing senior leader endorsement to drive agile development and DevSecOps throughout the Army. Under her leadership, the request for proposal process is changing to require the industry to incorporate modern software practices.

Prior to joining ASA(ALT), Ms. Swanson served as the Director of the U.S. Army Communications Electronics Command Software Engineering Center, which is headquartered in Aberdeen Proving Ground, MD.
